

TANGER MED GROUP AND CMA CGM SIGN PARTNERSHIP AGREEMENT



On Monday, October 28, 2024, alongside the ceremony for the signing of agreements between Morocco and France, presided over by His Majesty King Mohammed VI and Mr. Emmanuel Macron, Tanger Med Group and CMA CGM signed a strategic partnership for port development and maritime decarbonization. The agreement was signed by Mr. Fouad Brini, Chairman of Tanger Med Group, and Mr. Rodolphe Saadé, Chairman of CMA CGM.

The partnership covers the creation of a new transshipment platform at the Port of Nador West Med's EAST container terminal, recently awarded to Marsa Maroc in June 2024. This new entity will be operated as a joint venture, 51% by Marsa Maroc and 49% by CMA CGM, and will cover 50% of the terminal's infrastructure, i.e. 750 meters of quay and 35 hectares of terminal yard.

Under a 25-year sub-contract, CMA CGM Group and Marsa Maroc will make major investments to the tune of \$280 million to develop the terminal, with the goal of reaching an annual capacity of 1.2 million TEUs within the next six years, in support of CMA CGM's shipping alliance. The project includes a section devoted to maritime decarbonization, notably through the promotion of green hydrogen, in line with the "Morocco Green Hydrogen" (Maroc Hydrogène Vert) initiative.

This agreement marks an important step in consolidating Morocco's strategic role in international shipping and green economy.

IFC AND MIGA PARTNER WITH TANGER MED PORT COMPLEX TO EXPAND RO-RO TERMINAL



In a landmark announcement on November 4, 2024, IFC (International Finance Corporation) and MIGA (Multilateral Investment Guarantee Agency), two World Bank Group institutions, revealed a strategic partnership with Tanger Med Port Complex, leader in the Mediterranean and Africa. The aim is to expand the truck and passenger terminal, thereby strengthening Morocco's position as a regional and global trade hub.

This project is receiving a €197 million loan from IFC, including €47 million from the Joint Loan Portfolio Program. This financing, one of the first in the emerging markets port sector to be linked to sustainability criteria, focuses on gender diversity and the integration of renewable energies as key performance indicators.

The project is also backed by a group of international banks led by JP Morgan, with a commercial loan of €203 million. At the same time, MIGA will offer a 15-year guarantee to lenders against any risk of non-fulfilment of financial obligations, an initiative that reinforces investment security.

This initiative should increase the Port's capacity to handle over a million trucks a year, compared with 477,000 trucks units in 2023. In addition to expanding the terminal, the project will create new direct jobs and stimulate economic growth, contributing to the strength of Morocco's infrastructure sector.

Loubna Ghaleb, Member of the Executive Board and Director of Strategy at Tanger Med Group, said: "This project will significantly increase truck handling capacity and support export growth in key sectors, such as agri-food and industry, while consolidating trade relations between Morocco and Europe."

This partnership also represents an important step in the implementation of Tanger Med's strategy to become a sustainable and resilient infrastructure model. As part of its decarbonization plan, the Port is committed to increasing the share of green electricity and taking measures to counter climate risks, such as raising breakwaters and quays to deal with rising sea levels.

Hiroshi Matano, Executive Vice-President of MIGA, added: "This financial default guarantee project is a first for Morocco, and will help improve port infrastructure while supporting the productivity of State-owned enterprises."

David Tinel, IFC Regional Representative for the Maghreb, emphasized that "this project will strengthen Morocco's position as a strategic maritime and logistics hub linking markets in Europe, Africa, and the Americas, while attracting new investments in Moroccan infrastructure."

Tanger Med's expansion project is a perfect fit with MIGA's strategy to support resilient infrastructure and regional integration. This expansion will have a positive impact on several sectors of the Moroccan economy, consolidating the country's position in international trade.

Finally, with major events such as the African Cup of Nations in 2025 and FIFA World Cup in 2030 looming on the horizon, this project reinforces Morocco's ambitions on the world stage.

EBRD AND THE EU SUPPORT MARSA MAROC IN IMPROVING THE COMPETITIVENESS OF MOROCCO'S PORTS



The EBRD (European Bank for Reconstruction and Development) is investing in the Moroccan port sector with a financing package worth 690 million MAD (equivalent to €65 million) for Marsa Maroc.

The EBRD funds will finance the expansion of the capacity of multi-purpose terminals operated by Marsa Maroc in the ports of Casablanca and Jorf Lasfar, through infrastructure works to increase their handling capacity, as well as the acquisition of hybrid cranes and electric rail cranes. This operation will enable the expansion and operational optimization of these terminals as well as strengthen the competitiveness of the Moroccan economy.

This project improves the sustainability of these port infrastructures through the acquisition and operation of more efficient electric rail cranes, as well as through increased handling capacity, which should result in greater energy efficiency through reduced greenhouse gas (GHG) emissions per cargo handled. The sustainable dimension of this project is also underpinned by the civil engineering works at the Jorf Lasfar multi-purpose terminal, which will incorporate climate resilience measures into the design of the quays to reduce sensitivity to rising sea levels.

EBRD will also support Marsa Maroc's digital transformation through technical cooperation activities financed by the European Union, including the development and introduction of state-of-theart digital solutions at the Casablanca multipurpose

terminal, as well as a "gender-responsive" digital training program for Marsa Maroc Group employees.

The financing agreement was signed by Mrs. Odile RENAUD BASSO, President of EBRD, and Mr. Tarik EL AROUSSI, Managing Director of Marsa Maroc, who emphasized that "this financing will enable Marsa Maroc to improve the appeal of its terminals, provide its customers with sustainable port facilities and offer more capacity to better serve and strengthen the competitiveness of Moroccan trade". Ms. RENAUD BASSO declared: "EBRD is proud to support Marsa Maroc in this transformative journey, contributing not only to the modernization of important infrastructure for the country, but also the promotion of inclusive and sustainable growth in the Moroccan port sector. With over 95% of the country's trade carried out through its ports, the port sector is a cornerstone of Morocco's economic development." Ms. Patricia LLMOBART, EU Ambassador to Morocco, said: "With this joint operation, the EU is demonstrating its ongoing commitment to supporting the Kingdom of Morocco in promoting sustainable infrastructure as well as its digital transition. The EU and Morocco are committed to eco-friendly industrial value chains and maritime corridors. The Morocco-EU Green Partnership will allow us to take our shared commitment to combating climate change a step further, in particular with a low-carbon economy. Moroccan ports are essential for decarbonizing maritime transport and international trade."

DECARBONIZATION

TANGER MED PORT COMPLEX ACHIEVES 100% GREEN ELECTRICITY SUPPLY



Tanger Med is fully committed to the energy transition and has set its sights on carbon neutrality for all its activities by 2030. Within this framework, an ambitious decarbonization roadmap has been set up as of 2022, coupled with a 2 billion MAD investment program, with the major objective of covering electricity needs with renewable sources.

To achieve this goal, Tanger Med is adopting a two-pronged approach: on the one hand, the supply of renewable electricity; and on the other, the development of self-supply energy projects.

With regard to the first segment, as of January 1, 2025, Tanger Med Port Complex will be supplied with 100% green electricity. This renewable electricity is used to power ships in port, thanks to the Onshore Power Supply (OPS) infrastructure installed at the TC4 container terminal in the first phase, and which will be extended to the other quays of the Port Complex.

The installation allows ships to connect directly to green electricity at berth, eliminating carbon emissions for the duration of the call.

Other groundbreaking projects are also being rolled out to support the self-supply of green energy, including the installation of a 13 MW floating photovoltaic power plant, scheduled for service in 2025.

In December 2024, the Port Complex also obtained ISO 50001 certification, in recognition of the various energy efficiency projects it has launched.

These projects will enable Tanger Med to consolidate its competitiveness for the world's major shipping lines, logistics players, and industrial companies located within the Industrial Platform, and are also in line with the objectives adopted in the summer of 2023 by the International Maritime Organization IMO, which set carbon neutrality for the port and maritime sector by 2050.

PARTICIPATION IN THE HAMBURG SUSTAINABILITY CONFERENCE 2024



With the presence of Mr. Mehdi TAZI-RIFFI, CEO of Tanger Med Group, Tanger Med took an active part in the 1st edition of the Hamburg Sustainability Conference (HSC), which took place on October 7 and 8, 2024, at the City Hall and Chamber of Commerce of the city of Hamburg.

The event brought together world leaders from the political, economic, scientific, and civil society sectors, all united by the desire to take concrete action to achieve the UN's Sustainable Development Goals (SDGs).

Through insightful dialogue, trust-building, and collaboration focused on practical solutions, HSC has shed light on some of the world's most pressing challenges, while at the same time cultivating long-term, sustainable partnerships.

Structured around three main forums, five thematic hubs, and over 60 sessions, the conference enabled participants to reflect on new ways of reorganizing international financial systems, increasing investment in sustainable development, and harnessing innovation to generate transformational change. Together, they developed and defined concrete actions to build a sustainable future for all.

PARTICIPATION IN THE WORLD PORTS CONFERENCE 2024



The "IAPH 2024 World Ports Conference" was hosted during the 2024 edition by the Port of Hamburg from October 8 to 10, 2024. The event brought together key players in the global maritime supply chain, including port authorities, policymakers, ship and cargo owners, and service providers.

The conference offered crucial insights into how the world's ports are adapting to the energy transition and building secure, sustainable solutions in a rapidly changing global environment marked by increasing geopolitical instability and security threats. Discussions and presentations focused on risk management, building resilience, and creating new opportunities.

Tanger Med took an active part in the sessions and discussions, with Mr. Medhi TAZI RIFFI, CEO of Tanger Med Group, taking part in the "Port Leadership in Data Collaboration" panel alongside Mr. Jens Meier, CEO of the Port of Hamburg, and Mr. Eugene Seroka, Managing Director of the Port of Los Angeles.

PARTICIPATION IN THE 9TH EDITION OF THE X-MOROCCO SYMPOSIUM



Under the High Patronage of His Majesty King Mohammed VI, may God assist Him, the 9th edition of the X-Maroc Symposium was held on December 17, 2024 in Casablanca, with the theme "Morocco's energy future, challenges, and opportunities." The event brought together experts, government officials, and key industry players to discuss the strategies and innovations needed to meet tomorrow's energy challenges and capitalize on economic and industrial opportunities.

The plenary session featured a speech by Mr. Jamal Eddine M'Hamdi, Chairman of X-Maroc Group, who highlighted the major advances made in the energy transition, under the enlightened leadership of His Majesty King Mohammed VI, may God assist Him.

Ms. Leila Benali, Minister for Energy Transition and Sustainable Development, made a strong appeal for greater mobilization to support this radical change in operating mode, with the goal of reinforcing Morocco's investment appeal in this strategic sector.

PARTICIPATION IN THE 4TH EDITION OF THE ASFIM CONFERENCE



On November 13, 2024, the Moroccan Investment Management Companies' Association (ASFIM) organized a conference on the theme "Channeling National Savings to Stimulate Growth", bringing together the major players in the Moroccan financial sector at the Hyatt Regency Casablanca. This event provided an opportunity to discuss the challenges and opportunities of channeling national savings to support the country's economic growth.

Among those present were Nadia Fettah, Minister of Economy and Finance, Nezha Hayat, President of the Moroccan Capital Market Authority (AMMC), Brahim Touimi Benjelloun, President of the Casablanca Stock Exchange, and Réda Hilali, President of ASFIM. These leading figures shared their perspectives on the need for better management of domestic financial flows in order to boost productive investment.

The event was structured around three major panels: the first addressed the role of domestic savings in the Moroccan economy, the second focused on innovation in collective investment management, while the third explored the development prospects for asset management in Morocco.

During this last panel, Ms. Loubna GHALEB, Tanger Med's Strategy Director, contributed her expertise regarding asset management development, stressing the importance of structuring financial mechanisms tailored to the needs of the Moroccan market and local investors.

Discussions at the conference highlighted the importance of strengthening the mobilization of national savings, while innovating management tools and structures to promote sustainable investment and contribute to Morocco's long-term growth.

PARTICIPATION IN THE 3RD EDITION OF THE QATAR AFRICA BUSINESS FORUM

Tanger Med took part in the 3rd edition of the Qatar Africa Business Forum 2024, held in Marrakech on November 16 and 17, 2024, under the theme "Investing in AI for Tomorrow's Growth," exploring the impact of artificial intelligence for Africa's development.

This leading forum brought together influential figures and major organizations, providing an essential platform for dialogue and collaboration between Africa, Qatar, and other partners in the Middle East and beyond. On the Moroccan side, the forum was chaired by Aziz Akhannouch, Prime Minister, while Sheikha Al-Mayassa bint Hamad bin Khalifa Al-Thani, President of Years of Culture, honored the event with her presence, designating Morocco as a cultural partner for the year 2024.

The Qatar Africa Business Forum 2024 is part of the Qatar-Morocco Year of Culture 2024, underlining once again the depth of the strong and historic ties between the two peoples and between the two Heads of State,

His Majesty King Mohammed VI and His Highness Sheikh Tamim bin Hamad Al-Thani.

The forum brought together 350 eminent leaders from the private and public sectors, representing diverse interests essential to shaping Africa's future. This year's edition focused on the transformative power of artificial intelligence, with "Investing in AI for Tomorrow's Growth" as its main theme.

The main purpose of the forum was to accelerate South-South cooperation through joint projects focusing on artificial intelligence, technological innovation, and sustainability. Debates also focused on Africa's role in the global economy, with discussions centering on key sectors such as agriculture, smart urbanization, and renewable energies, as well as the preparation of sports and economic infrastructures for 2030, drawing on Qatar's experiences in hosting the 2022 FIFA World Cup.

ORGANIZATION OF THE 2024 ANNUAL MEETING OF THE AFRICAN SPECIAL ECONOMIC ZONES IN NAIROBI, KENYA



From November 27 to 29, 2024, Nairobi hosted the Annual Meeting of African Special Economic Zones (SEZs), organized by AEZO and the African Union Commission, in partnership with the Kenyan Ministry of Investment, Trade, and Industry. The event brought together over 400 participants, including ministers, policy-makers, and private sector players, to discuss the role of SEZs in Africa's economic transformation.

Under the theme "Building Resilient, Inclusive, and Sustainable Economies", the meeting explored how SEZs can attract sustainable investment, boost competitiveness, and contribute to global priorities such as climate action and food security. Africa boasts over 250 operational SEZs, generating \$3.2 trillion in investment in key sectors such as agrifood, automotive, and aeronautics.

The opening ceremony featured a keynote address by His Excellency Dr. William Samoei Ruto, President and Commander-in-Chief of the Republic of Kenya Armed Forces, followed by speeches by H.E. Albert MUCHANGA, African Union Commissioner for Economic Development, Trade, Industry, and Mining, the Hon.

Salim MVURYA, Cabinet Secretary of the Kenyan Ministry of Investment, Trade, and Industry, Mr. Mehdi TAZI RIFFI, President of AEZO, and Dr. Gunther BEGER, Director General of Innovation and Economic Transformation of the SDGs at UNIDO.

A Memorandum of Understanding (MoU) was also signed between AEZO and UNIDO to strengthen cooperation as well as SEZ capacities.

Discussions focused on themes such as innovation, sustainability, competitiveness, and the integration of regional value chains. Participants had the opportunity to visit emblematic Kenyan SEZs, such as Tatu City and Konza Technopolis, to discover best practices in management and development.

The event redefined the approach to SEZs in Africa, highlighting their potential to promote sustainable economic development and inclusive growth. Kenya, the meeting's host, continues to play a key role in the region's economic integration, with a dozen or so SEZs operational and numerous projects under development.

UNIDO AND AEZO WORK TOGETHER FOR THE FUTURE OF SPECIAL ECONOMIC ZONES IN AFRICA



The United Nations Industrial Development Organization (UNIDO) and the African Economic Zones Organization (AEZO), representing African SEZs, are joining forces to promote the development of these strategic zones. At the African SEZ 2024 annual meeting, the two organizations presented their joint report entitled "Characteristics, Trends, and Prospects for Special Economic Zones in Africa - Insights from a UNIDO-AEZO Survey."

Based on a survey of 63 SEZs in 26 countries, this report examines the current situation and explores the potential of African SEZs. It outlines three strategic recommendations for maximizing their economic impact:

- $\bullet \quad \text{Strengthening management structures to improve efficiency and attract more investments}.$
- Embracing digitization, an essential lever for boosting competitiveness and operational efficiency.
- Diversifying into high-growth sectors, such as tourism and ICT, thereby reducing dependence on traditional industries and creating new economic opportunities.

The report, financed by the European Union and the Secretariat of the Organization of African, Caribbean, and Pacific States (OACP) through the ACP Friend Program, offers valuable insights into the future of African SEZs.

At the event, UNIDO and AEZO also formalized their commitment to strengthening their partnership by signing a Memorandum of Understanding (MoU). This initiative is part of UNIDO's ongoing programs, in particular the African Special Agro-Industrial Processing Zones (ASAP-Z) initiative, launched at the Africa Investment Forum (AIF) last year. This initiative aims to transform rural areas into thriving agro-industrial sectors.

"Together, we aim to create an investment-friendly environment in which economic zones can prosper and unlock Africa's vast economic potential," said Mr. Beger at the signing ceremony. This enhanced cooperation will play a key role in the successful implementation of continent-wide initiatives supporting Africa's industrialization and sustainable development.



LAUNCH OF OPERATIONS AT TERMINAL 1 OF THE PORT OF COTONOU



On October 8, 2024, Marsa Maroc teams marked a key milestone in their development by handling their very first vessel at Terminal 1 of the Port of Cotonou. This symbolic event is part of the delegated management of Terminals 1 and 5 of this strategic port, entrusted to Marsa Maroc by Bénin Manutentions S.A. in July 2024, following an international invitation to tender.

This new milestone testifies to Marsa Maroc's expertise and commitment to supporting the modernization and optimization of port infrastructures in Benin. By working with Bénin Manutentions S.A., the goal is to enhance the attractiveness of the port of Cotonou, a veritable logistics hub in the West African region.

MARSA MAROC AND LIBERIA'S NATIONAL PORT AUTHORITY SIGN A MEMORANDUM OF UNDERSTANDING

On Tuesday, November 12, Marsa Maroc and the National Port Authority of Liberia (NPA) signed a memorandum of understanding (MoU) in Monrovia to strengthen Liberia's port infrastructure and increase its regional trade potential.

The 18-month agreement covers two main projects:

The development and operation of a new multipurpose terminal at the Port of Monrovia: The partnership aims to secure a public-private partnership (PPP) concession to develop a modern multi-purpose terminal. The terminal will be able to handle a wide range of cargoes, including dry bulk and break bulk, improving the operational efficiency and service capacity of Monrovia's main port.

- A concession agreement for the Port of Buchanan: The partnership aims to improve the Port of Buchanan's multi-purpose terminal, including the design, construction, financing, and management of this essential infrastructure to facilitate efficient cargo handling and support economic growth in the

region.

Under this protocol, Marsa Maroc and NPA will work closely together to assess current port operations, share their respective expertise, and finalize concession agreements.

PORT OF CASABLANCA: WORK BEGINS ON INCREASING THE DEPTH OF THE MULTI-PURPOSE TERMINAL



Work to deepen the multi-purpose terminal at the Port of Casablanca began last October. They concern Series 30 berths, which must reach a depth of -12 m/zh. This project is part of the development and optimization of port infrastructures at DEPC-TP.

The deepening of the quay will enable the terminal to accommodate larger Postpanamax vessels, capable of carrying large cargoes of up to 60,000 tons. This project represents a strategic lever giving the terminal a major competitive edge and enhancing its attractiveness to shippers and shipowners.

The project to deepen the multi-purpose terminal marks an important step in the development of the Port of Casablanca. It reflects the company's determination to adapt its infrastructures to the demands of modern maritime trade, while offering new prospects for its customers.

MARSA MAROC MODERNIZES ITS EQUIPMENT FLEET

Marsa Maroc strengthens its equipment with the acquisition of three wheeled mobile port cranes for €14 million.

These cranes, acquired from German manufacturer Liebherr, will be used to handle dry bulk and break bulk, as well as heavy packages and containers. They are destined respectively for Tanger Med Port (bulk and break bulk terminal), the Port of Casablanca (multipurpose terminal), and the Port of Agadir, and will have a maximum capacity of between 124 and 154 tons.

GREAT CASABLANCA MAKES ITS FIRST CALL AT DEPC-TCR



On Sunday, November 3, the Port of Casablanca welcomed the first call of Grimaldi Group's new 5th generation vessel, Great Casablanca.

To mark the occasion, an inauguration ceremony was held at the East Container Terminal in the presence of several officials, including representatives of the Ministries of Equipment and Water, Transport, and Logistics, the Italian Consul General, and the Chairmen of Professional Associations.

This 250-meter-long vessel, with its dual capacity for Ro-Ro and container transport, is a major asset for strengthening trade between the Port of Casablanca and the main ports of West Africa, while offering exceptional operational and ecological efficiency.

Great Casablanca is equipped with an optimized propulsion system for greater energy efficiency, reducing CO2 emissions per ton transported by up to 43% compared with the company's other multipurpose CONRO vessels.

Marsa Maroc is actively pursuing its development strategy to internationalize its activities.


PIPELINE TRAFFIC AT THE PORT OF SAFI

Since September 2024, the Operations Department at the Port of Safi has been handling import traffic in pipes designed to link the Safi desalination plant to the town of Youssoufia, as part of a strategic project to meet the region's water needs.

The 7 ports of call handled cargos of around 54,000 tons, i.e. 9,000 pipes weighing 6 tons each, handled with great care and precision due to their fragile nature. This project is part of a wider initiative to secure water resources, including infrastructure to bring water to rural areas affected by water stress.

The Safi seawater desalination plant, managed by OCP Group, plays a vital role in supplying the city with drinking water.

NEW TRAFFIC AT TANGER MED'S BULK AND BREAK BULK TERMINAL



On October 9, 2024, the DETVMD terminal at Tanger Med Port handled for the first time a livestock feed vessel on behalf of a new customer newly established in the region.

This first shipment of 3,850 T was processed by the teams with direct delivery by truck.

FIRST TWINNING OPERATION AT THE PORT OF NADOR

The Operations Team at the Port of Nador carried out its first twinning operation on November 16, unloading a cargo of 1,312 tons of heavy lift cargo using two cranes simultaneously. The cargo is destined for the new wind turbine blade production plant being built in the region by Chinese customer AEOLON.

Three stopouers are scheduled to import the plant's production tools and accessories. This first shipment involved various elements, including forms and bridges for moving packages inside the plant, measuring up to 44 meters.



RENEWAL OF DEPL'S COMPLIANCE DECLARATIONS WITH THE PROVISIONS OF THE ISPS CODE

The compliance of DEPL's port facilities with the provisions of the ISPS code was renewed in October 2024 by the Ministry of Equipment and Water, following an update of the security plan assessments for the Marsa Maroc multipurpose terminal at the Port of Laâyoune. This five-year renewal is part of the Terminal Safety Improvement program.

The International Ship and Port Facility Security (ISPS) Code, which went into force on October 1, 2004, under Chapter XI-2 of the SOLAS Convention, forms the basis of a comprehensive, mandatory security regime for the international shipping industry.

Specifically, the ISPS Code aims to create an international framework that fosters cooperation between contracting governments, government agencies, local administrations, and the maritime and port sectors, in order to assess and detect potential threats to the security of ships and port facilities used in international trade, and to implement preventive security measures against these threats.

TANGER MED PASSES THE 10 MILLION CONTAINER MARK

CONTAINER ACTIVITY: 10.24 MILLION CONTAINERS HANDLED

The Port Complex handled 10,241,392 containers* in 2024, an increase of 18.8% compared to 2023.

This performance is the result of the trust and commitment of port operators and shipping lines, as well as the high productivity levels achieved by all our teams.

This result was also achieved thanks to the upgrading of certain facilities, commissioning of new equipment, and optimizing maritime calls to reduce waiting and maneuvering times.

RO-RO ACTIVITY ON THE RISE

516,842 trucks were handled by Tanger Med Port in 2024, representing growth of **8.1%** compared with 2023. This traffic was mainly driven by industrial products, up **6.8%**, and agri-food products, up **7.2%**.

PASSENGER ACTIVITY: MORE THAN 3 MILLION PASSENGERS RECORDED

3,047,387 passengers passed through Tanger Med Port Complex in 2024, representing growth of **13%** compared with 2023. The Marhaba campaign, which is the main passenger transit period, performed optimally during its 2024 edition.

CONTINUED GROWTH IN NEW VEHICLE SALES

The Port Complex's two vehicle terminals handled a total of **600,872 vehicles in 2024**, an increase of **4%** on last year. This traffic includes 368,843 export vehicles produced by Renault's Melloussa and SOMACA plants in Casablanca, 170,519 vehicles exported by the Stellantis plant in Kénitra, 34,100 vehicles transshipped, and 27,410 vehicles imported.

SOLID AND LIQUID BULK TRAFFIC ON THE MOVE

Dry bulk traffic stagnated, with slight growth of **1%** over the previous year, totaling **584,945 tons handled**. At the same time, the volume of hydrocarbons reached **7,640,524 tons**, down **22%** compared with 2023. This decrease is mainly due to the transfer of part of the imports to the new storage facilities recently commissioned in other Moroccan ports.

OVERALL TONNAGE INCREASES

Tanger Med Port Complex handled **142 million** tons of goods in 2024, up **16.2%** compared with 2023.

MARITIME CALLS INCREASE

17,479 maritime calls were recorded at the Port Complex in 2024, up **3.42%** compared with 2023. These included **1,217 mega-ships** (over 290 meters in length), up **13.74%** compared with the previous year.

These results reflect the collective mobilization of port operators, local authorities, and administrations in the day-to-day management of the port, in order to keep pace with the major changes in world maritime trade.

MAERSK REVISES ITS ME2 SERVICE ROTATION



In October 2024, Maersk announced adjustments to the rotation of its ME2 service route, linking Northern Europe, the Middle East, and India. This modification, implemented from November 2024, removes Bremerhaven from the rotation.

The last ship to call at Bremerhauen on this service route was the CAP SAN SOUNIO, on October 11, 2024.

To compensate for this change, Maersk has set up a transshipment solution via Tanger Med. From now on, Bremerhaven will be linked to the Middle East and India via the Samba service route, which operates between Europe and the east coast of South America. This service route, which already includes Hamburg as a North German call, had integrated Bremerhaven at the beginning of 2024, reinforcing its connection capacities.

HAPAG LLOYD DECOUPLES EUROPE -WAF -ECSA-SAFT SERVICES



In October 2024, Hapag-Lloyd announced the separation of its combined "WWA/SAT" service, operating on the Europe - West Africa (WAF) - South America East (ECSA) - South Africa (SAF) routes. This decision marks a return to a configuration of two separate services, following the temporary merger of the two loops in May 2024.

From now on, two independent routes will cover these strategic connections:

- 1- "WWA" service (Europe West Africa):
- Calls: Anvers, Le Haure, Lisbonne, Tanger Med, Tema, Pointe Noire, Luanda, Anvers.
- Full rotation: 42 days.

2- Service "SAT" Service (Southeastern America - South Africa):

- Calls: Durban, Luanda, Tema, Paranagua, Itajai, Santos, Durban.
- Full rotation: 35 days.

This reorganization is designed to optimize lead times and regional coverage by meeting the specific needs of commercial flows on these two distinct routes.

ARKAS LINE LEAVES THE NORTHERN EUROPE - WEST AFRICA ROUTE

Turkish shipping operator Arkas Line officially ended its direct service on the North Europe-West Africa route in December 2024, after almost ten years of operations along this strategic corridor.

However, Arkas Line maintains a strong presence in West Africa via its Tanger Med hub, thanks to optimized services and strategic partnerships.

Up to the end of 2024, Arkas offered two main services on the North Europe - West Africa trade route:

- Tema Express (TEX): This service linked Le Haure to Tanger Med and Tema, via time slots on the Europe-West Africa WWA service operated by Hapag-Lloyd.
- Europe Tanger Service (ETS): This offer connected Europe to West Africa via transshipment at Tanger Med, with calls at Rotterdam, Wilhelmshaven (temporarily replacing Hamburg), Antwerp, then back to Rotterdam via Tanger Med.

These two services, which have now been discontinued, have given way to a strategy refocused on Tanger Med, enabling Arkas to continue serving West Africa competitively.

Since January 2025, Arkas Line has relied on two new services via time slots on lines operated by Hapag-Lloyd:

- West Africa Service (WAS): This service covers a wide network linking Tanger Med, Dakar, Lagos, Cotonou, Abidjan, Tema and back to Tanger Med, using Hapag-Lloyd's WAX (Tanger Med - West Africa) service.
- Morocco Export Service (MES): This more specialized service links Tanger Med to Nouakchott, and is based on Hapag-Lloyd's WA1 (Tanger Med - West Africa) service.

Arkas Line's decision to consolidate its activities via Tanger Med reflects the growing importance of the Moroccan port complex as a hub for trade between Europe and West Africa. By relying on this hub, Arkas Line guarantees the continuity of its services and meets the growing needs of African markets, while also optimizing its operational resources.

With this reorganization, Arkas Line continues to play a key role in the development of maritime trade between Europe and West Africa, while reinforcing Tanger Med's logistics capabilities as a regional hub.

HAPAG LLOYD EXTENDS "JDX" SERVICE TO TURKEY



Hapag-Lloyd recently extended the coverage of its Europe - Red Sea service, the "Jeddah Express" (JDX), by including Turkey in its itinerary. This strategic development marks an important step in strengthening maritime connections in the Mediterranean and beyond this revised rotation, with an inaugural departure on November 23, 2024 from Jeddah.

As part of this expansion, new calls in Mersin and Yarimca have been added to the northbound route. Furthermore,

Tanger Med will now replace Valencia, consolidating the Moroccan port's key role in Hapag-Lloyd's global network

To support this expansion, a sixth vessel, the LITTLE EMMA, has been added to the operational loop. The new JDX service rotation includes the following ports: Anvers, Valence, Damiette, Djeddah, Damiette, Mersin, Yarimca, Tanger Med, and back to Anvers.

SYNERGY ANTWERP was the first ship to follow this revised rotation, with an inaugural departure on November 23, 2024 from Jeddah.

ARKAS LINE BOOSTS CABOTAGE TRAFFIC IN MOROCCO WITH ITS "MCS" SERVICE



Last December, Arkas Line, via its feeder branch EMES, increased the frequency of its intra-Moroccan cabotage service, known as "Morocco Cabotage Service" (MCS). This strategic development is part of the expansion of the Turkish operator's activities in the region, with several significant innovations.

The revised "MCS" service now includes new ports of call:

- Another stop at the Port of Casablanca.
- A stopover in Algeciras, thus extending our geographical coverage.
- A Northbound stopover at Tanger Med.

With the addition of the "ONUR G.A" $(1,440\,\text{TEUs})$ on December 19, 2024, Arkas/EMES has changed the frequency of service from every 13 days to weekly.

The revised service is now operated by two 1,440 TEUs vessels, with a rotation via: Valencia, Tanger Med, Casablanca, Algésiras, Tanger Med, Casablanca, Valencia. The official launch of the new service was marked by the departure of the "CASABLANCA A" ship from Valencia on December 23, 2024.




RALLYE AFRICA ECO RACE 2025: EUROPE AND AFRICA CONNECTED THROUGH TANGER MED PORT

- Draft Contract Creation and Consultation: In this phase, a draft contract (EDC) is drawn up and published directly on the system, enabling stakeholders to consult and validate the content before formalization with the successful supplier.
- Contractualization and Commitment: Automatic contract generation, approval and signature (internal and external) will be greatly simplified, guaranteeing a smooth, error-free process.
- Contract Execution and Monitoring: Finally, this
 phase covers all the processes required for contract
 execution, including the management of service
 orders, renewals, and amendments. Ongoing
 monitoring will ensure compliance and proactive
 management of contractual commitments.

Two main tools are used to ensure optimal contract management:

- Contracts Console: This centralized dashboard will provide an overview of all current contracts within the Group, enabling transparent management and real-time monitoring.
- Alerts and Notifications: The system will trigger alerts to anticipate deadlines and ensure that all necessary actions are completed on time.

The purpose of this project is to harness real-time data to improve reliability, efficiency, and decision-making in the management of critical infrastructures.

Developed in collaboration with maintenance teams, TMPA's IT team, and an external service provider, this project focuses on the real-time capture and analysis of OT data, with specific applications such as cathodic protection and instrumentation. The main objective is to ensure constant monitoring of critical equipment to guarantee its proper operation and prolong its service life.

Real-time OT data capture and analysis enables constant monitoring of equipment, detecting anomalies immediately. Centralized management of critical equipment ensures reliable real-time control, enabling rapid intervention in the event of a problem. The project also aims to optimize maintenance, reducing costs by replacing expensive and less sustainable solutions with more efficient management.


The operational impact on the port includes:

- · Consolidating critical data facilitates rapid, informed decision-making.





- Centralized registration management: A centralized process for registering customers, users, and visitors, guaranteeing better monitoring and control of access.
- Integration with Oracle: The system is now connected to Oracle, enabling automated invoicing of services linked to badges and key cards, simplifying administrative management.

Future outlook:

- Integration with external organizations: There are plans to work with entities such as NSSF (National Social Security Fund) and NARSA (National Road Safety Agency) to extend functionalities and facilitate administrative procedures linked to access management.
- Strengthening digital services: The system will continue to evolve to offer even smoother, more secure solutions tailored to the growing needs of economic operators.

This modernization represents a key step towards boosting productivity, improving safety, and delivering an optimal user experience.

NEW PRIVATE INVESTMENTS

In 2024, Tanger Med Industrial Platform attracted a total investment of **10.06 billion MAD** and the creation of a cumulative **14,034 new jobs**.

As for the zones developed by "Tanger Med Zones", 95 new industrial projects representing a private investment of 3.63 billion MAD and creating 11,239 new jobs have been confirmed in 2024.

Among the major companies established: German automotive suppliers ZF, the world's second-largest, specializing in advanced mobility solutions, and MUBEA, introducing the production of carbon fiber preforms. Romanian MP Industry, specialized in plastic injection, and American Gentherm, specializing in climate control and comfort products, also contribute to strengthening Morocco's automotive ecosystem. French company Dachser will develop logistics services, particularly for the automotive sector.

Additionally, SFC Solutions, specializing in the production of sealing components, American APTIV, Japanese NSK, specialized in manufacturing steering system components, Turkish Standard Profil, and Spanish BAMESA, specialized in stamping and steel product distribution, have reinforced their presence through new industrial expansions.

BUSINESS VOLUME OF SECTORS OPERATING AT TANGER MED

In 2024, the business volume generated by Tanger Med's Business Park reached 174 billion MAD, representing a significant increase of 12.3% over the previous year. This growth was reflected in various sectors:

- 117 billion MAD for the automotive sector, an increase of 10.38% compared with 2023
- 10 billion MAD for other industrial sectors, including textiles and aeronautics, down 11.11% from 2023.
- 46 billion MAD for the logistics sector, an increase of 15% compared with 2023.

Tanger Med Business Park includes the zones managed by Tanger Med Zones, a subsidiary of Tanger Med Group, and the new Mohammed VI Tanger Tech City, managed by SATT, a partnership between Bank of Africa (BMCE), Tanger-Tétouan-Al Hoceïma Regional Council, Tanger Med Group, and the Chinese company CCCC-CRBC.

So far, these zones have been developed over a footprint of 3,000 HA, hosting more than 1,400 companies and creating almost 130,000 jobs in over 10 sectors: automotive, aeronautics, textiles, healthcare, agri-food, electronics, renewable energies, packaging, services, and logistics.

MOHAMMED VI TANGER TECH CITY

As for the "Tanger Tech" zone, which has so far been developed over an area of 87 HA, 4 new players have confirmed that they will be setting up in 2024, for an investment of 6.43 billion MAD and creating 2,795 new jobs, including the Chinese BTR New Material Group, which specializes in the production of materials for lithium-ion batteries, and holds the exclusive title of simultaneous world leader in the production of anodes and cathodes.

TI Automotive, a leading American business in the manufacture of engine supply and fluid handling systems, has set up in Tanger Automotive City. The project represents an investment of 60 million MAD and covers an area of 17,000 m². It will create 450 jobs, contributing to the growth of the Moroccan automotive industry and the development of local expertise.

TANGER FREE ZONE

AEW AUTOMOTIVE SYSTEMS



The Chinese group AEW Automotive Systems, which specializes in research, development and manufacture of automotive accessory parts, is moving into the Tanger Free Zone (TFZ). This project illustrates the Group's commitment to improving the safety and comfort of motorists, while meeting the growing demands of the global automotive industry. With more than 180 patents registered in these fields, AEW Automotive Systems is a leading innovator.

This move to Morocco, which becomes the Group's sixth host country after the United States, Germany, France, Japan ,and Romania, marks a key stage in its international expansion. The project will cover an area of 4,200 m², represents an investment of MAD 27 million and will create 181 jobs.

TÉTOUAN PARK



Tétouan Park continues to strengthen its industrial ecosystem with the arrival of new set up projects. These initiatives cover a wide range of sectors, from optics and mechanical engineering to metal recycling and furniture production.

- Global Optique: Specializing in the manufacture of glass and optical products, this business will set up on an 815 m² site with an investment of 8 million MAD, creating 25 jobs.
- Arkea: Focusing on the manufacture of furniture and outdoor decorative items, the business will also invest 8 million MAD to set up on 853 m², generating 15 jobs.
- MLM Metal: A player in the recycling and transformation of aluminum, this project will cover an area of 4,368 m², with an investment of 20 million MAD and the creation of 35 jobs.
- Miral Nord (expansion): As part of its expansion, this mechanical manufacturing business will invest MAD 6 million to add 1,332 m² to its facilities and create 10 additional jobs.
- Morela Morocco: Specializing in the manufacture of medical scopes, this company will set up in 3,193 m², with an investment of 7 million MAD and the creation of 25 jobs.

These projects underline the attractiveness of Tanger Med's Industrial Platform for investors, offering a framework conducive to innovation and sustainable development in a variety of sectors.

INAUGURATION OF MP INDUSTRY IN TANGER AUTOMOTIVE CITY



On November 22, 2024, MP Industry Group, a subsidiary of MEN Industry Group specializing in the manufacture of plastic components for the automotive industry in Romania, inaugurated its first plant in Tanger Automotive City, within Tanger Med's Industrial Platform.

The inauguration ceremony was presided over by Mr. Ryad Mezzour, Minister of Industry and Commerce, in the presence of Mr. Ahmed Bennis, Managing Director of Tanger Med Zones, Mr. Jean Drugescu, Chairman and CEO of Metaplast and MP Industry Group, Mr. Dan Iacoban, Managing Director of MP Industry Group Morocco, and other senior Moroccan officials.

Covering an area of 35,000 m², this project involves the construction of a plant specializing in the manufacture of plastic parts using granulate injection technology in steel molds, for an investment of 437.623 million MAD and the creation of 150 direct jobs.

On this occasion, Mr. Mezzour welcomed the inauguration, which is of strategic importance for the development of the national automotive industry. "This project, developed as part of the Renault ecosystem, demonstrates once again the attractiveness of our industrial platform. The arrival of the MP Industry group in Morocco will play an active part in the deployment of the vision outlined for the sector: that of expanding local value chains

and increasing our production base. This plant, which is equipped with cutting-edge technology, will help consolidate our competitive position by promoting the local production of automotive parts." "We reiterate our unwavering support for MP Industry Group to further strengthen their presence in Morocco," he adds.

Mr. Ahmed Bennis, Managing Director of Tanger Med Zones said: "We are particularly delighted with this partnership with MP Industry and the Romanian investors. Our ambition is to contribute to strengthening their international competitiveness while continuing to promote the industrial integration of the Moroccan automotive sector."

For his part, Mr. Jean Drugescu said: "With the growth of the automotive industry and the potential of African markets, MP Industry Group is at the dawn of a promising future, particularly in Morocco. Thanks to the support of the Moroccan authorities, we are convinced that we will be able to strengthen our integration in the Moroccan automotive industry and proudly carry our slogan: "We are Moroccans."

In line with its vision and the major importance of sustainability in the sector, the group has taken care to equip its plant with photovoltaic panel systems, but also with several shredding and recycling lines for plastic waste.

MARSA MAROC LAUNCHES CABOTAGE OPERATIONS

Marsa Maroc began cabotage operations in October 2024 in partnership with LafargeHolcim Maroc. This partnership provides for the implementation of an integrated logistics solution, including the coastal shipping of clinker between the ports of Agadir and Laâyoune, and its handling at both ports.

A cabotage operation makes it possible to transfer almost 6,000 tonnes of clinker between Agadir and Laâyoune by sea shipment, instead of several truck journeys previously required to transport similar volumes overland.

Switching to sea transport not only reduces CO2 emissions and relieves congestion on the roads, but also allows us to increase the volume and fluidity of flows, reduce the rate of loss of goods

during transfer, and ensure the safety of goods and the reliability of transit time. Ultimately, all these benefits enable customers to better manage their Supply Chain.

This approach confirms Marsa Maroc's determination to include environmental issues in its development projects, and to establish CSR as an essential component in supporting its partners in their sustainable growth strategy.

This project will enable Marsa Maroc to kick-start its development in coastal shipping, in line with its 2030 development strategy, which positions Marsa Maroc as a benchmark port, logistics and maritime partner in Morocco and Africa, offering integrated, digitized and sustainable solutions.

MARSA MAROC STRENGTHENS ITS COMMITMENT TO ART

TANGER MED FOUNDATION

TANGER MED FOUNDATION CONTINUES ITS CATARACT TREATMENT CAMPAIGN FOR THE PEOPLE OF FAHS ANJRA



Launched in December 2023, this medical program aims to combat cataracts in Tanger Med Group's main activity zones, notably the Fahs Anjra Province. This initiative is being carried out in collaboration with local authorities, associations, and private players in Tangier's health sector.

Cataracts, an eye condition that particularly affects rural populations, are one of the main causes of avoidable blindness. The purpose of this initiative is to significantly reduce the prevalence of this disease, while improving the quality of life of those affected.

AREAS OF INTERVENTION

The campaign is divided into three main phases, each designed to maximize the impact of the operation:

1. Survey and Assessment

A qualified medical team travels directly to the douars of the Fahs Anjra province to carry out cataract screening. Identified patients are made aware of the problem and helped to regularize their social situation, before being referred to partner organizations in the health sector of Tangier. To date, over 1,000 people have been screened in the province.

2. Regularization of Mandatory Medical Insurance (AMO) status

Tanger Med Foundation provides administrative assistance to enable screened patients to regularize their AMO status, thus facilitating their affiliation to social security organizations in Morocco. More than 7,771 households have already benefited from this awareness-raising and regularization operation.

3. Medical Intervention

Over 300 people have already benefited from checkups and cataract surgery. These patients also received medical and administrative support for their social care. The costs of the partner clinic are covered jointly by Tanger Med Foundation and the beneficiaries' mutual insurance companies.

This initiative reflects Tanger Med Foundation's commitment to improving the health and quality of life of local populations, while helping to reduce inequalities in access to healthcare in rural areas of Morocco.

ORGANIZATION OF AN AWARENESS-RAISING WORKSHOP FOR DAR TALIBA AND DAR TALIB MANAGERS



As part of its initiatives to strengthen educational support, Tanger Med Foundation organized an awareness-raising workshop on the theme of "Conscious and Benevolent Communication." The workshop, held on November 30 and December 1, brought together the 22 managers of Dar Taliba and Dar Talib establishments in the Fahs-Anjra province.

The main objective of this training was to enhance the communication skills of the managers, in order to improve exchanges with the middle and high school students living in these boarding schools. "Dar Talib" and "Dar Taliba" are boarding schools that provide an educational framework for pupils from isolated villages, giving them access to local education and high-quality pedagogical support.

The awareness-raising sessions focused on compassionate and respectful communication techniques, which enable us to better supervise students while promoting their personal and academic development.

TANGER MED FOUNDATION PROMOTES DIGITAL CULTURE IN FAHS ANJRA PROVINCE



In line with Morocco's Digital Strategy 2030, which places digital transformation at the heart of national priorities, Tanger Med Foundation has supported digital training for 50 beneficiaries at the Ksar Al Majaz youth economic integration platform in the Fahs Anjra province.

Supported by the Chôala Association, this initiative combining theory and practice took place under the aegis of the Chamber of Commerce, Industry, and Services of the Tangier-Tétouan-Al Hoceïma region, in partnership with the National Initiative for Human Development (INDH) of the Fahs Anjra province and the provincial youth directorate.

The aim of this training cycle is to use digital technology as a lever for development. It has been designed around six workshops spread over four days on November 9, 10, 16, and 17, 2024, covering topics such as artificial intelligence, office software, game development, editing, and 3D design.

The training concluded with the presentation of certificates by the training partners, all convinced of the importance of enriching the skills of young people and facilitating their professional integration.

TANGER MED FOUNDATION SUPPORTS THE MOROCCAN LEAGUE FOR CHILD PROTECTION (LMPE) IN M'DIQ IN THE LAUNCH OF 3 PRE-SCHOOL CLASSES

The Moroccan League for Child Protection (LMPE), a national organization that has been working to protect vulnerable children and safeguard their fundamental rights since 1954, is receiving support from Tanger Med Foundation for the launch of three new pre-school classes.

These classes are integrated into the "Noujoum Al Bahr" Educational Complex, located in the Foul El Olliq district of M'diq. The center, launched in early 2024, is designed to meet the needs of families in the area, particularly those facing economic hardship. Tanger Med Foundation's initiative is in line with its desire to contribute to the development of education, and to provide a favorable learning environment from an early age.



FOR THE SECOND YEAR RUNNING, DALIA SAILING SCHOOL WELCOMES STUDENTS FROM THE NATIONAL "STUDIES AND SPORTS" PROGRAM



Launched in 2019 by the Ministry of National Education, Preschool, and Sports, the "Studies and Sports" program aims to combine studies and sport by introducing a sports track into the academic curriculum, starting in the first year of middle school and extending right up to graduation.

Within the framework of the agreement signed between the Ministry and "Dalia Nautical Sports Association," Dalia's Sailing School has welcomed, for the 2024/2025 school year, 24 students from the Abdelkrim El Khattabi Middle School in Ksar Al Majaz, part of the Fahs Anjra regional directorate, who receive three weekly sessions.

Equipped with the necessary facilities and qualified staff, Dalia's sailing school supports the Ministry's program by offering students the right framework and infrastructure to study and practice sailing.

The polyphonic choral singing workshop, better known as the Melloussa Choir, was launched by Tanger Med Foundation more than five years ago. Since its inception, this workshop has enjoyed growing success, and continues to attract the enthusiasm and commitment of the children.

In partnership with the association "The Soul of Tangier Association for Choir, Art, and Culture," Tanger Med Foundation has decided to renew this workshop for the 2024/2025 season. The aim of this initiative is to offer children a space where they can practice music, exchange ideas and enjoy a friendly atmosphere, while fostering their personal development, social cohesion and the promotion of musical culture. Currently, 22 schoolchildren are benefiting from this program.

Additionally, a second workshop, dedicated to piano, was launched last year with the aim of making this instrument accessible to a wider audience. Following its success, this workshop has also been renewed. It currently has 15 beneficiaries.
